#### **CAN launches new Bellingham Employment Hub**

CAN is very pleased to announce we have received a grant of £15,000 from the European Social Fund (ESF) to set up a new Employment Hub in Bellingham, along similar lines to those we already run at Haltwhistle and Prudhoe.



The Employment Hub will provide support available to anyone living in Bellingham and the North Tyne Valley who is looking for employment. Our drop-insupportgroupwillbeopenevery Tuesday morning from 10am-1pm at Bellingham Town Hall. We'll be

in the community room which can be accessed from the door next to the library on the Manchester Square side of the building (this is the opposite side of the building and downstairs from the main entrance).

Group members will be able to access the internet to carry out job searches, benefit from one to one careers guidance, help with completing CVs and job applications, and support with improving IT skills. A free lunch and refreshments will be available and we may be able to offer travel expenses for those coming from outlying areas.

On Tuesday afternoons we are able to offer 1-1 appointments in local venues for anyone from outlying areas who

does not have access to transport into Bellingham.

#### ECO scheme subsidises boiler replacements

As winter approaches we are reminded how cold homes can severely affect the health and well-being of vulnerable and lower income households. Community Action Northumberland working in partnership with North East based 0800 Repair are raising awareness of opportunities so as many qualifying households as possible benefit from a warmer and healthier home this winter.

In April 2017 the Government's Energy Company Obligation scheme (ECO) introduced a new opportunity to help qualifying off-gas rural home-owners or private tenants to have inefficient

Oil or LPG boilers (7 or more years old), and inefficient Electric Storage Heaters replaced completely free of charge or generously subsidised.

The ECO scheme also subsidises the replacement of older gas boilers and offers free or generously subsidised Loft, Cavity Wall and Attic Room Insulation. UK Building Regulations advise Loft Insulation should be 270mm / 10ins deep.

Note: ECO is a Government regulated scheme to help qualifying home-owners and private tenants replace older inefficient boilers / electric storage heaters and insulate homes. All replacement boilers funded by ECO come with a full manufacturer's warranty supported by 1 year full install warranty and 24/7 breakdown cover.

CAN would like to thank all the residents of Corsenside, Elsdon, Otterburn and Rochester & Byrness Parishes who took the time to complete the transport survey we delivered to every household as part of the Getabout project. We were delighted to receive 126 completed surveys a response rate of 15%. Our staff are now busy analysing the results and hope to publish initial findings in October. Once complete reports will be sent to everyone who requested one, and we will be working the local parish councils to identify appropriate solutions to meet the needs identified. #### Thropton's new Warm Hub making people glow

CAN's award winning Warm Hubs project has expanded into Thropton, holding its first successful lunch in September.

Warm Hubs is an innovative project by CAN to help support communities across rural Northumberland by investing in their local facilities and providing training to volunteers. Within a Warm Hub people can be assured of finding a safe, warm and friendly environment in which to enjoy a healthy, good value meal, the company of other people and social activity as well as access to information and advice if needed.

Thropton War Memorial Hall is now holding Warm Hub lunches fortnightly. Lunch will be soup and a roll plus a pudding, tea and coffee, costing £4. The lunch is organised by Vikki Ewen and

supported by a range of volunteers from Thropton WI, local Churches and Thropton residents.

Pupils of Thropton Village First School will be joining the Hub from time to time, coming to chat, sing and play board games. Further occasional entertainment and recreations planned include local musicians, guest speakers and health and social care specialists. There is also a regular book swap.

Getting to the Hub has been made easy with the Upper Coquetdale Community Bus offering transport to the Hall by collecting local residents from either Phillips Newsagents or the Library in Rothbury. Thropton Warm Hubs co-ordinator Vikki Ewen said of the launch: "I am thrilled that thanks to the help of Christine Nicholls at CAN, generous support from Lesley Leeson and Thropton First School, we have been able to start our fortnightly lunches. It is a fabulous concept and one which can only bring good, positive things to the folk who come along or volunteer. More volunteers are always welcome to help out either with food or just coming along and chatting to people."

Twenty Warm Hubs have been rolled out in rural Northumberland with further hubs planned for urban areas in Newcastle, all supported from the outset and funded by Northern Gas Networks.

#### Community-led housing - spreading the word

Over 50 people attended three workshops we held in Alnwick, Hexham and Stannington during September to explain how local communities can take the driving seat in seeking to deliver affordable homes for local people.

Community-led housing schemes have six main features:

- They put local communities in the driving seat.
- They are usually small scale
- Although most schemes are usually set up and run by local people in their own communities
- They provide genuinely affordable homes for rent, shared ownership, sale or self-build
- Schemes meet long-term local housing needs
- Community-led housing is not for profit, involving considerable voluntary effort

Parish and Town Councils potentially have a key role in supporting or providing community-led housing schemes. Over the summer, we carried out a survey of local councils which produced some interesting results including:



- 54% of Parish and Town Councils in Northumberland want to see more affordable homes provided for local people in their areas; only 13% do not
- 77% of Parish and Town Councils feel high property prices is the main issue behind the lack of affordable homes; 25% feel community opposition is the main issue for them
- 19 Parish and Town Councils say they can identify pieces of land they feel may be suitable for small community-led housing schemes and most are aware of their ownership
- 26 Parish and Town Councils are keen to know more about community-led housing and how they might help provide it locally

With funding made available by Northumberland County Council from their allocation of the government's Community Housing Fund, we are able to provide direct support to community organisations in investigating the potential of community-led housing and bringing specific schemes to fruition. # Volunteer drivers needed

#### Our Clive says give it a shot!



Northumberland transport access scheme Getabout is looking to recruit more volunteer drivers to help meet growing need in particular the rural West and North of the county.

Run by Adapt (North East) with support from Community Action Northumberland and funded by Northumberland County Council, Getabout is a free service for people having difficulty getting out and about.

The service offers information and advice to help people access existing community transport schemes and public transport services, but can also provide a volunteer driver who will drive their own car to transport people to essential services such as health appointments.

Getabout volunteers are paid 45p per mile for taking people in their car to a pre-booked destination and will receive appropriate training.

Clive is a volunteer driver for Getabout, taking people in his own car on journeys they'd be unable to make without some support. Here he tells us what the role involves, and why he'd recommend it to anyone looking to give something back to their community in a flexible way.

"I'm a fairly busy bloke, but when I saw the advert in a local newsletter requesting volunteer drivers it struck me as something I could fit into my life pretty easily, with a great deal of flexibility and minimum training. I'd been considering doing some volunteering ever since I retired 4 years ago, and this type of work is ideally suited to someone like me, as the service is mostly needed during the day when people have appointments to get to."

"I was invited to a day's training in Hexham, covering the basics such as what to do if your car breaks down, how to handle people, that sort of common sense thing. It also covered dealing with expenses such as petrol costs and car parking charges, as we get reimbursed for all of those."

"So, a couple of times a week, I pick people up and take them to where they need to be, it's as simple as that."

"I help one gentleman on a regular basis which I enjoy. I take him on a Friday afternoon to visit his wife in a residential care home 20 miles away. He couldn't get there himself as there's no public transport available and it obviously means a lot to them both to keep this visit going. I leave him there for a couple of hours then pick him up, which is convenient for me as I use that time to get the weekly shop in!"

"For me I feel it's a really vital role for the simple fact that there are a significant number of people in the community with little or no access to reliable transport, which is where Getabout comes in. That's when I can 'step into the breach' and help these folk."

"I certainly get a real kick out of helping make their journey and their day easier. Going somewhere new or on your own can seem simple to most of us, but can be very nerve-racking for an elderly person. I don't just drop them at the door, I like to help them to where they need to be in the hospital before leaving them in someone else's hands. That makes the difference, using a bit of common sense and being fairly sociable."

"For those thinking about volunteering, I'd say give it a shot! Every person I've taken has been appreciative of the effort, happy such a valuable service exists."

CAN provides a facilitation role to the North East Communityled Development Network. The Network brings together people from across the region to share experiences of community-led development in all its forms and to get access to the latest information and intelligence.

#### **CAN** secures senior government official visit to North East

In this role we have managed to secure a visit to the region from Nigel Kersey, a senior civil servant at the Department for Communities and Local Government responsible for matters including the government's Community Housing Fund, as well as Matt Dodd who is the rural housing lead for Homes England (formerly known as the Homes & Communities Agency) – the government's agency which distributes the £6 billion affordable homes programme.

A special session of the network in December this year will hear the latest news from the heart of Westminster on government plans to support community-led housing development, including the best ways to access the resources available.

### Supporting sustainable local development



The Federation of Northumberland Development Trusts (FoNDT) have produced a Review to highlight the great work the various trusts do right across Northumberland, FoNDT exists to assist Northumberland's 17 local Development Trusts "to create

a self sustaining enterprising culture which enables local communities to be resilient and have the ability to control and shape their own futures."

CAN supports these trusts in a variety of ways. For example, every Friday we operate our Prudhoe Employment Hub from Prudhoe Community Partnership's Spetchells building in the centre of the town and earlier this year we helped Hexham Community Partnership to access funds from a number of sources to facilitate the continuation of a key project.

In Haltwhistle, we provide project officer services to Haltwhistle Partnership to manage their various activities. This has included a major project to refurbish a significant building in the centre of the town to create a ground floor retail unit along with 4 low cost flats to rent above and the community asset transfer of a County Council building to facilitate the growth of a highly successful local youth project.

Newcastle University's latest rural research and conference is a timely reminder for government and Local Enterprise Partnerships that ignoring the potential contribution of rural enterprise to the national economy would be a mistake as post Brexit policy is developed. Their new analysis of rural firms across the country and hosting the 15th pan-European Rural Entrepreneurship conference shine a bright light on the value, complexity

and opportunities surrounding enterprise in a rural context.

The University's analysis of 13,403 small firms in England, including 3,555 rural firms, interviewed for the UK Small Business Survey in 2015 (Small Rural Firms in English Regions: Analysis and Key findings from UK Longitudinal Small Business Survey) shows rural businesses in England are significantly more likely to be profitable than businesses in urban areas - and this is nothing to do with differences in sectors, size, age and other business characteristics of rural and urban areas.

Rural firms are also shown to be significantly stronger exporters of goods and services, are more likely to have introduced new or improved goods in their businesses, and are more able to secure external funds, especially for capital investments in machinery and buildings, than are businesses in urban

Obstacles to success of significantly more concern to rural businesses than urban are revealed to be regulations or red tape, staff recruitment and skills. and taxes, rates and National Insurance. Clear evidence is also identified of untapped rural potential with, for example, more rural firms having goods or services suitable for exporting than which currently export. #### **Our Rural Connect**

The recent international rural enterprise conference hosted by Newcastle University highlighted a number of novel approaches from across Europe. One such project was Rural Connect, an initiative which operates across the rural North East and is facilitated by CAN. Rural Connect provides a network for 37 separate rural enterprise hubs around rural Northumberland, Durham and the fringes of Tyne & Wear. This enables joint promotion to take place,

networking and sharing of good practice across the hubs. Critically, Rural Connect also offers a simple interface for the North East Local Enterprise Partnership and other business support providers with a network which reaches deep into the rural North East. This offers a clear opportunity to communicate the various forms of business support available to the hubs, their tenants and businesses within their wider networks.

#### Wingates Wind Farm community fund

CAN administers the Wingates Wind Farm Community Fund which provides grants of around £30,000 a year for the local community throughout the life of the wind farm.

At their September meeting the local panel awarded two new grants to local projects:

- St Giles Church Netherwitton have been awarded a grant of £2496 to resurface their car park and a the path joining the car park to the church. These were in a state of disrepair and the work will mean that everyone using the church and especially wheelchair users and parents with children in buggies will have better access to attend services, social and cultural events at the church.
- Rothley & Hollinghill Parish Council were awarded £2,000 to install a defibrillator in a disused telephone box next to The Gate Pub. This is a very rural area and the pub is

used by visitors to the area including walkers, cyclists and motor cyclists visiting the beautiful Simonside Hills. The installation of the defibrillator

will ensure that local residents and visitors who experience a heart attack will have access to life saving first aid treatment as early as possible whilst waiting for medical help to arrive.

£30,000 worth of funding is available each year and applications will be considered at quarterly meetings. The application deadlines and meeting dates for 2017/18 are on our website.

invited Applications are constituted voluntary and community groups, parish councils and schools carrying out projects which will be of community benefit within the parishes of Brinkburn & Hesleyhurst, Longhorsley, Netherwitton, Nunnykirk, and Rothley & Hollinghill.

Grants will normally be in the range of £250 to £2,000 and can be used to



support a wide range of activities including, education, culture, arts, science. sport, environmental protection, sustainable transport, improvements community to buildings etc.

The panel meets quarterly, with the next deadline for applications being Monday 13th November, with the next panel meeting date to be held on Monday 4th December. Future dates are on the CAN website under 'Empowering Organisations' > 'Local Grant Schemes'.
